Welcome Agenda



The focus of our first full assembly is 7 day services and during the day you will hear about and be able to discuss, the expectations, opportunities and challenges of delivering 7 day services. Clinical Senate has a significant role to play in offering independent clinical advice during significant service change. In order to reduce variation and deliver higher quality, efficient care for patients, 7 day working is a key component for many services. This assembly meeting should not only enhance the knowledge and understanding of the attendees regarding what is currently in place, and what should be prioritised but also enable the attendees to contribute to the knowledge base of the assemble as a whole.

The NHS is committed to improving access to core NHS services 7 days a week to address the significant variation in patient outcomes reflecting when patients are admitted to hospital at weekends and out of standard hours.

Sir Bruce Keogh, Medical Director of NHS England, has set out a plan to drive 7 day services across the NHS over the next three to five years.

The plan sets out ten clinical standards for urgent and emergency care and supporting diagnostic services, which all patients should expect as a minimum, 7 days a week.

Each standard is supported by clinical evidence and developed in partnership with the Academy of Medical Royal Colleges. Five of the ten standards will be in every clinical contract for delivery by March 2016 and the remaining five for delivery by March 2017.

Jane graduated from Nottingham University with the first UK Masters in Assisted Reproductive Technology. In her substantive role as a consultant reproductive scientist she is responsible for the scientific service for the diagnosis, management and treatment of infertility patients at the Leicester Fertility Centre. She is also the Human Fertilisation & Embryology Authority (HFEA) Person Responsible and is a founder member of the Association of Clinical Embryologists (ACE) and sits on the Executive committee for ACE.

In April 2014 Jane was seconded as Deputy CSO (acting) working closely with the Chief Scientific Officer (CSO) and senior colleagues at NHS England and is actively involved in the CSO work programme, focusing on leadership, quality, innovation and commissioning of diagnostics as well as working with NHSIQ for the delivery of 7 day scientific services.



Celia Ingham Clark Director for Reducing Premature Mortality at NHS England.

Trained in general and colorectal surgery, Celia was appointed Consultant in 1996 and has held several senior posts including Director of Medical Education, Clinical Director, Director of Operations, Trust Medical Director, and Medical Director of Whittington Health integrated care organisation.

Celia has also held national clinical lead roles for colorectal cancer, and for transforming inpatient care under the Cancer Services Collaborative and later NHS Improvement.

Celia's particular interest is in supporting and implementing quality improvements in patient care.



Professor, Sir Bruce Keogh Bruce became the National Medical Director for NHS England in April 2013.

He is responsible for the clinical and professional leadership of doctors, dentists, pharmacists, scientists and allied health professionals; improving clinical outcomes and promoting innovation.

Before taking up his national leadership role in 2007, he was an associate medical director at University Hospital Birmingham prior to becoming Director of Surgery at The Heart Hospital and Professor of Cardiac Surgery at University College London.

In a distinguished career in surgery, he has been President of the Society for Cardiothoracic Surgery in Great Britain and Ireland, Secretary General of the European Association for Cardiothoracic Surgery and a Director of the US Society of Thoracic Surgeons. He has served as a Commissioner on the Commission for Health Improvement and the Healthcare Commission and was knighted for his services to medicine in 2003.

Patrick also has responsibility for E-Learning for Healthcare, a Department of Health sponsored programme for clinical e-learning packages across the NHS. and directs the Better Training Better Care programme, which seeks to implement the recommendations of the Temple and Collins reports on the delivery of medical education and training.

Patrick has held the role of Chief Operating Officer/Deputy Chief Executive at St Georges Healthcare NHS Trust in south London, Director for Operations at the Royal Brompton and Harefield NHS Trust and has been a management consultant with PriceWaterhouseCoopers health practice in San Francisco.
